

# SUPPLEMENTAL TERMS AND CONDITIONS OF SALE UNDER THE LILETTA® VOLUME DISCOUNT PROGRAM<sup>1</sup>

## PRODUCT AND PRICING<sup>2,3,4</sup>

Under the LILETTA (levonorgestrel-releasing intrauterine system) 52 mg Volume Discount Program (the “LILETTA VDP”), a customer may purchase LILETTA (as described below in **TABLE 1**) from Allergan at the quantity-based discounts from Wholesale Acquisition Cost (“WAC”) listed below in **TABLE 2**. For the purpose of calculating the price applicable to a customer order, WAC shall be the WAC in effect at the time the order is received by Allergan.

Allergan, in its sole discretion and without prior notice, may at any time discontinue the LILETTA VDP, modify these LILETTA VDP terms, including discounts and volume requirements, or change the WAC for LILETTA.

LILETTA VDP discounts may be subject to reporting requirements under state and federal Medicaid and Medicare laws, including but not limited to, the Federal Anti-Kickback Act, SSA § 1128B(b)(3) and the discount safe harbor, 42 C.F.R. 1001.952(h). LILETTA VDP discounts are not intended in any way to limit or otherwise affect the objectivity or professional judgment of the purchaser or to interfere with the objectivity or professional discretion of any prescriber. Purchases of Product under the LILETTA VDP are for the purchaser’s “own use” and not for sale or resale to any person other than its own patients or for distribution or dispensation outside of the United States. Purchaser and Allergan shall comply with all applicable laws in respect of all transactions under the LILETTA VDP.
